



Regulatory framework at EU and national level




- «The aim of an EPR system is to ensure that packaging placed on the market is responsibly managed throughout its life cycle. This is achieved by shifting the responsibility for managing waste generated by product consumption to the companies that place those products on the market.»
- Those responsibilities include:
 - improved product design,
 - prevention,
 - reuse preparation for re-use,
 - recycling,
 - and driving changes in societal behavior.



Definition of non-household packaging


Non-household packaging waste refers to waste that does not come from households or from establishments whose waste is collected and treated in the same way as household waste:

- Tertiary packaging (stretch film, single-use pallets, corner protectors)
- Secondary/grouped packaging (cardboard boxes, cases, jerrycans)
- Primary packaging of products designed for the exclusive use of professionals(generally packaging for products > 10 kg / 10 L)
- Reusable packaging




Definition of producer

- *Translation: established in the Grand Duchy of Luxembourg which, in a professional capacity, fills or sells directly in the Grand Duchy of Luxembourg, whatever the sales technique used, including through distance contracts as defined in Article L. 222-1 of the Consumer Code, and places packaged products on the Luxembourg market.*




Definition of producer

- b) qui est le **premier acteur** à réceptionner, à titre professionnel, des **produits emballés importés** au Grand-Duché de Luxembourg par toute personne physique ou morale établie ou non au Grand-Duché de Luxembourg, quelle que soit la technique de vente utilisée, y compris par le biais de contrats à distance tels que définis à l'article L. 222-1 du Code de la consommation, **et met sur le marché luxembourgeois des produits emballés**; ou
- b) which is **the first actor** to receive, in a professional capacity, **packaged products** imported into the Grand Duchy of Luxembourg by any natural or legal person established or not in the Grand Duchy of Luxembourg, whatever the sales technique used, including through distance contracts as defined in Article L. 222-1 of the Consumer Code, and **places packaged products on the Luxembourg market**; or”



Definition of producer

- c) établie en dehors du Grand-Duché de Luxembourg qui, à titre professionnel, vend des produits emballés au Grand-Duché de Luxembourg directement à des ménages ou à des utilisateurs autres que des ménages, quelle que soit la technique de vente utilisée, y compris par le biais de contrats à distance tels que définis à l'article L. 222-1 du Code de la consommation ; c)
- established outside the Grand Duchy of Luxembourg which, in a professional capacity, sells packaged products in the Grand Duchy of Luxembourg directly to households or to users other than households, whatever the sales technique used, including through distance contracts as defined in Article L. 222-1 of the Consumer Code;



Obligations

- Loi modifiée du 21 mars 2017 relative aux emballages et aux déchets d'emballages
 - Art. 6 (1) *“Producers are required to meet the minimum recycling rate targets.”*
 - Art. 8 *“For non-household packaging, the producer must appoint a producer responsibility organisation (organisme agréé) to carry out all or part of these obligations on its behalf”*
- Loi modifiée du 21 mars 2012 relative à la gestion des déchets
 - Art.19 (7) The producer responsibility organisation has also:
 - 1) to carry out prevention and reuse measures;
 - 3) to ensure transparency of waste flows, in terms of quantities and destinations, treatment methods, and collection, recycling, and recovery rates;
 - 5) to register its members with the competent authority and to keep the list up to date.

Why Valorlux? Shared resources, Shared compliance

By pooling member resources, Valorlux enables your company to fulfil its EPR obligations for packaging at a competitive cost



Calculation of **national recycling rates** by combining **put-on-the-market** data with **collected packaging** quantities in Luxembourg



Traceability of packaging streams to their final destination - **Auditing of traders and final recyclers**, which may well take place beyond the borders of the European Union



Implementation of **PPWR requirements** to ensure that our members remain **compliant**



Prevention measures to **reduce packaging** quantities and comply with legal objectives



Incentives to encourage the **sorting** of industrial packaging and achieve the recycling objectives in the different laws

1. Which packaging is affected?

Which industrial packaging?

The declaration of industrial packaging is made in mass quantity per type of packaging

Industrial Green Dots

Paper Cardboard



Plastic



Wood



Metal



What is industrial packaging?

- Tertiary packaging (stretch film, single-use pallets, corner protectors)
- Secondary packaging (cartons, boxes, drums) excluding multipacks
- Primary packaging for products designed for professional use only (generally packaging for products >10 [kg]/[L])

Industrial packaging must be declared, in units of mass, on the platform Valbase Online

2. Operational model


Which industrial packaging?

Industrial packaging includes not only finished products but also the packaging of purchased products

You are responsible for finished products placed on the Luxembourg market,
but also for packaging that you import if your supplier is not a member of
Valorlux

How to declare industrial packaging?

Valbase offers two methods for declaring industrial packaging based on the information you have available

Method A

Declaration of mass based on **product data sheets** or **consumption**

- Applicable to all packaging for items for which the **theoretical weight** of the packaging is **known** from **product data sheets** or **annual consumption data** (e.g. stretch film consumption)



Method B

Declaration based on the mass collected in **waste containers**

- Applicable to all packaging of items for which the **theoretical mass** of the packaging is **unknown**
- The declaration is then made on the basis of the **certificate** you receive for the recovery of this waste by your **sanitation company**



The Valbase Online reporting tool

The declaration is made online on the Valbase platform for four packaging materials

Waste recovery certificates





Who does what in the Extended Producer Responsibility system?

Valorlux coordinates the system in order to meet legal requirements. Your company may have one or more roles at the same time: unpacker, packaging responsible, or both?



You manage your waste as usual. Valorlux takes care of other procedures such as reporting, waste traceability through to recycling, and recycler audits to ensure your compliance.

3. Conclusions and next steps

What should I do?

Become a Valorlux member and submit your declaration of packaging put on the market for the year 2025 before 28 February

- 1 Each responsible for packaging will be required to provide an annual declaration of packaging placed on the market. The declaration must be made by the **end of February 2026** in relation to your **company's activity in 2025**.
- 2 Become a member of Valorlux quickly in order to fulfil your obligations by using the following link:

- 3 If you are eligible for bonuses, your approved collector will take care of most of the steps required to receive them. All you need to do is validate the bonus on the home page of Valbase and it will be paid to you.
